2. PA Department of Human Services: \$23.00

6. PA State Police - Act 235 Lethal Weapons Training Program: \$25.75 or \$75.75.

Applicant Data Security

Data is encrypted and traveling over a secured network that is regulated by the State and Federal government standards for this type of data communication.

ACT 114 Clearance Certification

PA Department of Education: The Applicant FBI background clearance check record is normally available within 48 hours of fingerprint submission to school districts and non public schools. Applicants/Contractors must provide the school entity the PA Identification number provided by Cogent Systems at the completion of registration or at the fingerprinting site to have their record reviewed by the school entity. The official record is obtained by the school district for all employees and contractors. If the district hires the employee or certifies a contractor record they are not permitted to copy that official record for the applicant or contractor. The unofficial copy is sent to the Applicant/Contractor for informational purposes. The official record is valid for one year.

PA Department of Public Welfare: The applicant should receive the official FBI background clearance check record in the mail approximately 2-4 weeks after the completion of the fingerprinting.

 ARIN IU 28 is located on West Pike (Business Route 422), approximately three miles west of Indiana, PA.

DIRECTIONS

- ◆ **From the Southeast (Harrisburg, Philadelphia)**
 Pennsylvania Turnpike West to Bedford (Exit 146); I-99/Route 220 North to Route 22 West; Route 22 West to Route 219 North (Ebensburg); Route 219 North to Route 422 West to Indiana; take the Philadelphia Street Exit; turn right at the exit ramp stop sign, and drive 0.6 mile to the top of the hill. The ARIN Regional Office is on the left-hand side of the highway (approximately three miles west of Indiana). The distance from Ebensburg to ARIN is approximately 32 miles.
- ◆ **From the Northeast (Scranton, Wilkes-Barre)**
 Interstate 80 West to Route 220 South; I-99/Route 220 South to Route 22 West; Route 22 West to Route 219 North (Ebensburg); Route 219 North to Route 422 West to Indiana; take the Philadelphia Street Exit; turn right at the exit ramp stop sign, and drive 0.6 mile to the top of the hill. The ARIN Regional Office is on the left-hand side of the highway (approximately three miles west of Indiana). The distance from Ebensburg to ARIN is approximately 32 miles.
- ◆ **From the Southwest (Pittsburgh)**
 Route 22 East to Indiana Exit (Route 119 North - near Blairsville); Route 119 North to Route 422 West to Indiana; take the Philadelphia Street Exit; turn right at the exit ramp stop sign, and drive 0.6 mile to the top of the hill. The ARIN Regional Office is on the left-hand side of the highway (approximately three miles west of Indiana).

- ◆ **Alternate Route from the Southwest (Pittsburgh)**
 Route 28 North from Pittsburgh to the Kittanning Exit; right onto Route 422 East to Indiana (approximately 25 miles); near Indiana, take the Philadelphia Street Exit, and drive 0.6 mile to the top of the hill. The ARIN Regional Office is on the left-hand side of the highway (approximately three miles west of Indiana).
- ◆ **From the Northwest (Erie)**
 Route I-79 South to Route 422 East; follow Route 422 East to Indiana; near Indiana take the Philadelphia Street Exit, and drive 0.6 mile to the top of the hill. The ARIN Regional Office is on the left-hand side of the highway (approximately three miles west of Indiana).
